- A1 CONCOURS:** Applies only to cars entered or being prepared for entry to concours competitions.
- A2 TOP CLASS:** The components are in immaculate condition and free of all but the most trivial faults. This can only be applied to cars in near concours condition.
- A3 VERY GOOD CONDITION:** The car is in excellent order and is maintained to a high standard. There may be small imperfections
- A4 AVERAGE:** All components are in good working order, capable of regular use and of satisfying all MOT requirements. A respray would not go amiss.
- A5 SERVICEABLE:** The components are serviceable but a considerable amount of work will be necessary to sustain regular use. The car will be roadworthy and able to pass an MOT test.

Details of any restoration should be given in full and photocopies of any receipts for major works or repairs to the car should be supplied where possible. A minimum of four clear photographs showing the car from opposing corners, the interior, and the engine bay, must be supplied. Polaroid photographs are not detailed enough and are not acceptable. The history of the car may well be pertinent to the valuation. A low mileage car, a car with one owner from new, or a car with full service history, may be worth more than an apparently comparable car.

The replacement value is an estimate of what it would cost to replace the car with one in similar condition, excluding personalised number plates and items such as radios.
